**Returns:**

1. Products may not be returned without a prior Return Authorization Number from BLUEWATER SECURITY PROFESSIONALS
2. The Return Authorization Number must appear on your return packing label and on the outside of the box. (The Return Authorization Number is valid for 30 days)
3. When calling to request a Return Authorization Number, be prepared to provide:
  - The Reason for the request
  - The Serial Number of the product
  - The invoice number
4. If a product is defective, it is the decision of BLUEWATER SECURITY PROFESSIONALS as to whether to authorize a return of the product for a credit, replacement, repair, or direct the customer to the manufacturer for resolution of the problem.
5. All returns for credit must be made within 30 days of the invoice date. The decision of whether the credit will be granted is solely that of BLUEWATER SECURITY PROFESSIONALS
6. All returns for credit must be 100% complete, in a new condition, properly packaged in the original boxes, with all manuals, warranty cards, cables, packing materials, and other accessories provided by the manufacturer. A 10% restocking charge will be applied for all products not returned in original form/package
7. No returns for credit are permitted on software, and consumable products that have been used, and/or opened, also on "Special Order" products (A "Special Order" product is a product that BLUEWATER SECURITY PROFESSIONALS does not normally keep in stock and that was ordered specifically for a particular customer.)
8. When a product is returned, the customer is responsible for freight and insurance. All returns must be insured for the full value by the customer. The customer is liable for any damage resulting from improper packaging of the product being returned.
